LOOKING FOR EXHIBITORS

This is a Thursday thru Saturday Event (No Sunday). You do not have to be an experienced exhibitor, just willing to display your items and allow numismatists to enjoy and learn from it. An American Silver Eagle will be awarded to all non-winning exhibitors and judges. First Place Awards will be U.S. Mint 1/10th oz gold coins for high score in each exhibit class. Second & Third Place Awards to be determined.

Class 1 - U.S. Coins, Class 2 - World Coins, Class 3 - Numismatic Paper, Class 4 - Exonumia Class 5 – Medals and Tokens, Class 6 – Mint Errors and Altered Coins

Judging will be by ANA Certified Judges. All exhibit cases will be locked and security will be on site at all times. Exhibits may be placed on Wednesday after 3:00pm or Thursday from 9:00am - 12:00noon. Exhibits must be removed on Saturday from 2:00pm to 5:00pm.

You must be a member of PAN to exhibit. Each exhibitor will be allowed a maximum of 2 exhibits not to exceed 10 total cases. Exceptions may be made with prior notice and approval from the exhibit chairman.

PAN members interested in exhibiting or that have any questions please contact Exhibit Chairman Jeff Rose (412) 977-3717. The registration deadline is October 1st. All winner's certificates and prizes will be presented at on Saturday October 18 in the exhibit area at 1:30pm. Ribbons will be affixed to the winning exhibit cases.

EXHIBIT RULES

- 1. Exhibit applications must be received no later than October 1, 2025.
- 2. All exhibits are to be placed by 12:00pm on Thursday October 17 and are not to be removed without permission of the Exhibit Chairman prior to 2:00pm on Saturday October 18, 2025.
- 3. It is understood that the exhibit case(s) will be opened **ONLY** by the exhibitor with the Exhibit Chairman present.
- 4. All keys are to be retained by the PAN exhibit chairman.
- 5. All materials in a display must be the exclusive property of the exhibitor.
- 6. Any material in a display that is not genuine must be so identified.
- 7. The name or identity of exhibitors shall not appear on exhibits.
- 8. No exhibit shall contain advertising for items that are for sale.
- 9. The right is reserved to restrict material outside of the exhibit case(s), which might distract attention from other exhibits.
- 10. Exhibitors may enter up to Two Exhibits of up to 10 cases maximum or discuss more cases with Exhibit Chair Jeff Rose (412) 977-3717.

RECOMMENDATION: The inside case dimensions are exact. If using a foam board or something similar 20.50" X 32.25" will allow it to sit freely and should not interfere with the lock mechanism.
